## **Incident Management**

In the event of an incident, you will find emergency numbers and instructions on the various postings.



## **Web based Training**

After the external employees have successfully completed the "Web-based Training" (WbT), the helmet stickers are filled out by the respective Holcim contact person.


- → Name of the external employee + Month in which the WbT will be expired (valid for 1 year)
- The employee attaches the sticker to the helmet.
- The aim of the helmet sticker is to immediately trace who has completed the WbT and who has not yet completed the training. This should significantly increase the transparency of our WbT.

## **Traffic regulation / Parking inside the plant**

- One-way traffic in the cement plant
- Follow signs
- Park backwards and only in marked areas (blue markings) or in designated areas
- Maximum speed limit 20 km/h
- Parking card must be attached (issued by contact person)
- General obligation to wear seat belts



## Safety rules when unloading

- 1. Get Holcim OK before unloading.
- 2. The unloading area is free of people and vehicles.
  - → Exclusion zone next to truck= 15 m
- 3. Keep truck and trailer in a straight line.
- 4. Stay in the truck with your seat belt on.
- 5. Only tip when all wheels are on level ground.
- 6. Only drive forward slowly with the tipper set up.
- 7. Lower the tipper completely before driving away.

## Comply with legal and the following internal Holcim requirements:

## Working at height

- Personal suitability and professional training for work with a risk of falling and use of personal protective equipment against falls
- Use of tested PPE such as 4-point chin straps, helmet, safety harness, ropes, etc
- Use of:
- o Industrial and mobile cranes
- o Construction machinery (loaders, dumpers, excavators, etc.)
- o Aerial work platforms
- o Industrial trucks (forklifts)
  - Legally Required Training
- Instruction in Holcim work equipment if required
- Special PPE when working on grinding machines and angle grinders
  - Wearing safety goggles, hearing protection and a full visor is mandatory
- Special PPE for assembly work in the factory
  - Use of cut-resistant gloves is mandatory (exception for special work in consultation)

Please note that only work equipment that has been tested and is intact, e.g. hoists, cranes, PPE, pressure vessels, etc. (see test books) should be used.

Holcim reserves the right to carry out random checks.

## **Safety Briefing**

Safety talk daily before starting work or when the contact person changes.

Access to the maintenance premises during the revision is strictly limited!

A maximum of 2 people per company have access to the premises.

## E-workshop / Metalworking shop including machinery / Car workshop

- The group of people is firmly defined and controlled
- Group of people can only be changed in consultation with the IH manager

## Accessibility to the magazine – issue of spare parts or tools

- Group of people must be defined for each company
- Depending on the weather no issue via the locksmith access

#### **Chromate - General Information**

- The use of high-alloy steels in the clinker burning process (e.g. anchors and immersion tubes) can lead to the formation of chromate.
- In certain concentrations, chromate can be toxic, hazardous to water and carcinogenic.
  - Relevant areas are essentially refractory work, replacement of metal parts or demolition work in the area of the heat exchanger tower/furnace.
  - In cold conditions, chromates can often be easily identified by their yellow-green discoloration.
  - With sensitization of the affected groups of people, the identification of affected areas and the appropriate PPE, we can safely carry out our planned activities.



#### **Chromate - Taking action**

- Separation of contaminated and clean clothing
- Separation and identification of the black and white areas
- Schwarz-Bereich
- Regularly and clearly declaration of chromate areas
- Mandatory use of the dust extraction cabin
- Special storage of dismantled materials
- Special disposal of all contaminated PPE and materials
  - Consistent implementation and monitoring of the measures
